Minutes of the Meeting for February 27, 2018

Chair's Welcome: Professor Maude called the meeting to order at 11:17 am.

Approval of CUSA Minutes: A motion was made to approve the February 13, 2018 meeting minutes of the Committee on Undergraduate Studies & Advising. The motion was seconded and passed.
